- Dust, mud and erosion control plan;
- Proposed truck routes;
- Written confirmation from the Nottawasaga Valley Conservation Authority that the proposed Works are not taking place on land to which a regulation under Section 28 of the Conservation Authorities Act, R.S.O. 1990, c.C.27, as amended, applies;

- A signed authorization by the Owner allowing the Operator to conduct the proposed Works on the Owner's land, if applicable;
- A signed acknowledgement by the Owner and Operator certifying the correctness of all the information in the Permit Application;
- Signed authorizations of any grantees of any easements on the property agreeing to the Works on or in the vicinity of the easement.

***Note: Additional information may be required by the Director in order to obtain a Permit. Please refer to Section 4.5 of the 2018-006 Cut and Fill By-law.**
