The 2018 Interim Tax Bills will be mailed by January 31. Installment due dates are:

**February 21, 2018 and April 18, 2018**

If your mortgage company pays your property taxes, you will not receive a tax bill.

## Water and Wastewater Rates

**Residential Water Rates** in 2018 will remain the same as in 2017.

**Residential Wastewater Rates** will increase 3.7% (on average) effective February 1, 2018.

**Non-residential Water Rates** will increase 2.4% (on average) effective February 1, 2018.

**Non-residential Wastewater Rates** will increase by 4.4% (on average) effective February 1, 2018.

**TAKE NOTICE** that the Council of The Corporation of the Township of Springwater will hold a Public Meeting at 6:30 PM on February 7, 2018 in the Council Chambers located at the Administration Centre at 2231 Nursery Road.

**THE PURPOSE** of the Public Meeting is to obtain public comments on a proposal to update Building Permit fees. A proposed fee increase will be based on an adjustments of existing fees established in Schedule "B" of by-law 2015-033 and Schedule "E" of by-law 2015-034 with Statistic Canada Construction Price Index records with some minor adjustments on certain fees. This meeting is being held pursuant to Section 7 of the, Building Code Act, 1992.
